# Instruction Book Overview

Chevron is pleased to continue the tradition that started over 20 years ago. The Delo Tractor Restoration Competition provides high school students with the opportunity to learn and grow through a comprehensive tractor restoration. This is a national competition and tradition that engages students, family, advisors, and the entire community. Student teams of one or more, preserve the past by locating an old tractor that was once a valuable workhorse on a farm and restoring it to its former glory. In addition to the actual tractor restoration, students learn valuable life skills they will carry forth after graduating from high school. Some go on to career positions upon graduation as a result of their experience in their restoration and in the competition.

Chevron is excited to offer this competition and the opportunity for recognition and prizes for high school students, whether they are in FFA, 4-H, Skills USA, or just interested in agriculture or the restoration process. The competition awards prizes up to \$20,000 with recognition of the Grand Champion, Reserve Champion, and Third Place, as well as other recognition for photography, best presentation, and online video votes.\*

Teams must document their tractor restoration experience in a workbook and submit a short video showing the tractor running, along with before and after pictures. The submissions go through two stages of judging. All entries are evaluated by tractor expert judges to determine the top twelve who will become finalists. These twelve teams will present their projects in person to a panel of judges during the annual FFA Convention held in October of each year. Students need not be FFA members to compete. The competition is open to all high school students.

\*The online video vote does not impact the outcome of the competition.

# **ELIGIBILITY**

All high school students are eliaible to compete in the Chevron **Delo Tractor** Restoration Competition. Any student on the team may graduate during the academic year prior to the competition deadline in August and still compete in finals if the team is selected.

Transforming a pile of rusty parts into an award-winning, restored tractor is a challenge. But the rewards will be big and last far longer than the restoration!

- **Step 1:** Find an old tractor, take pictures of your old tractor where you found it previous owners if known. Take several shots to show the condition it was in when you found it. The tractor must have an internal combustion engine.
- Step 2: Restore the tractor and document your restoration progress as you go along. Take lots of photos throughout the process to record your work. You will need to include photos with captions in your workbook—include as many as you like to tell the story, but a few photos in each section may be enough. Be sure to show off your paint and finishing work in your photos the judges like to see the completed product! Be sure and take notes throughout your restoration about what you found and learned. Your notes will help you prepare if you are selected as a finalist.
- Step 3: Create a short (3-4 minutes) video so the judges can see and hear your tractor come to life. The video will also help the judges get to know more about you and your experience, as well as see the restored tractor runs, and the instrument gauges are working. There is more information about the video submission on page 19, as well as the video contest on page 21.
- **Step 4:** When your project is complete, take several "after" project photos. Remember the 2019 competition includes a Best Photo prize! Be sure to compose your "after" photos so they are beautiful shots ready to frame. See page 20 for details of photos specifications.
- **Step 5:** Submit your completed workbook, five of your best photos including one of you or the team with the completed tractor, plus a couple that show your tractor before the restoration. You will also need to submit your video. Submission details can be found on page 35.

The program is designed to be a **high school student** competition. While adult supervision, mentoring and assistance is important, the restoration should be completed by the participating student(s).

# **COMPETITION REGISTRATION**

To register for the competition, you will need to complete and mail two forms (pages page 7-8):

Remember: Early registration lets us know to look for your entry submission.

- 1. Registration Information—this can be one form for the entire team. Be sure to list mobile phone number (if available) for the advisor and at least one student or parent so we can reach you if we have questions about your submission.
- 2. Release Agreement. One release agreement must be filled out for each student who is involved in the project.

# 2019 COMPETITION WORKBOOK & SUBMISSION PROCESS:



TRACTOR RESTORATION COMPETITION

The Workbook template, sometimes referred to as the record book, has been designed in Microsoft Word® and provided to assist you in documenting your project. In the following pages of this instruction book, you will find all the information you need to successfully document your project and complete the materials needed for a valid electronic submission. Make sure to read through this instruction book carefully and follow the tips before beginning your workbook and prior to submission to ensure you have documented the required contents.

Follow the workbook outline, but you may add as many photos as you like and additional pages of description to document your restoration project. Photos help tell the story of your project and document the work throughout the process, so use as many photos as you like. Remember: while detail is important, keep your workbook content clear and concise. **It's best to limit your workbook to about 50 - 100 pages.** If you have a lot of pictures to show, use the best ones that tell the story and **use captions** with your photos so it's clear to the judges what you are trying to show or communicate.

Hint: As you plan your restoration effort think about resources outside your school or team that might offset areas of expertise your team does not have. For example, if you don't know how to use Microsoft Word® is there someone who can help? Or if you need help with your video, or PowerPoint presentation, etc., could you find someone to help you learn? Don't forget social media is a great way to engage the community in your project!

# **GETTING STARTED**

It's a good idea to start out organized and plan to document along the way. Some teams find that keeping a master book or binder to record their work, time, and expenses is helpful. In particular, set a budget up front and try to manage that budget. Identify how you might get donated goods and services. Remember, it's not how much you spend on the project that makes a winning restoration—it's the work performed and what you learned.

# **WORKBOOK CONTENTS**

The following sections should be covered in your workbook or recordbook of your restoration. Keep in mind your tractor is unique so the following general outline of required workbook contents may vary for your tractor.

### **ENGINE**

- Summarize the overall condition of the engine before you started working on the tractor.
- Did it run? Were any tests performed to determine its condition?
- Was it stuck? How was it disassembled without damaging components?
- Describe in detail what was involved in the restoration of the engine, including but not limited to, cylinder bores, pistons, bearings, valves, etc.
- Support your narrative with pictures, include captions with the pictures.
- Highlight any interesting or unusual features of the engine.

# **TRANSMISSION**

- Summarize the overall condition of the transmission before you started working on it. Include any of the following that apply: clutch, torque convertor, torque amplifier, hydrostat drive, etc.
- Describe in detail what was involved in the restoration of these components. Some examples might be bearings, seals, gears, clutch linings, clutch packs, etc.
- Support your narrative with pictures, include captions with pictures.
- Highlight any interesting or unusual features of the transmission.



Your cover should include your team name, and a nice picture of your tractor and/or your team with the tractor.



### **FINAL DRIVE**

- Summarize the overall condition of the final drive before you started working on it. Include any of the following that apply: differential, ring and pinion, axles, steering clutches (e.g. crawler tractors), etc.
- Describe in detail what was involved in the restoration of these components, such as bearings, gears, shafts, seals, etc.
- Support your narrative with pictures, include <u>captions</u> with pictures identifying what you are trying to show.

# ANCILLARY SYSTEMS\*

- Summarize the overall condition of the ancillary systems before you started working on them. Include any of following that apply: fuel system, cooling system, governor, ignition system, steering system (wheels or tracks), brakes, electrical charging system, starting system, etc.
- Describe in detail what was involved in the restoration of these components.
- Support your narrative with pictures, include captions with pictures.
- Highlight any interesting or unusual features you discovered while rebuilding these components.

\*Ancillary Systems are components that are primary to the function of the tractor.

### **AUXILIARY SYSTEMS\*\***

- Summarize the overall condition of the auxiliary systems before you started working on them. Include any of the following that apply: seat, hydraulic system, 3-point hitch, power take off, lighting, instrumentation, wheels or tracks, cab with heating and air conditioning, etc.
- Describe in detail what was involved in the restoration of these components, seat suspension parts, hydraulic seals, valves, piping, pto clutches, gauges, cab upholstery, etc.
- Support your narrative with pictures, include captions with pictures.
- Highlight any interesting or unusual features you discovered while rebuilding these components.

\*\*Auxiliary Systems are those supporting systems for the tractor usefulness.





## **EXTERNAL APPEARANCE**

- Summarize the appearance of your project before you started working on it. Was sheet metal missing, dented, rusted through, does it have a cab and what condition is it in, condition of the grill and fenders, etc.?
- Describe in detail what was involved in the restoration of the hood, fenders, grill, etc. Was body work performed? Was welding required? Was glass replaced in the cab? What were the steps used in painting? Were decals and emblems purchased?
- Support your narrative with pictures, include captions with pictures and shots that show the sheet metal fit and finish.

## LABOR REPORT

- This report should accurately document the hours <u>you</u>
  have spent on your project <u>along with hours worked by</u>
  <u>others</u> who helped including engine, electrical, diesel, or
  other machine shop services used.
- This report is an important part of the workbook and should include the date work was performed, who did the work, brief description of work performed, hours spent that day and any resources used.
- Please total the hours used at the end of the report.
- See page 16 for an example format for your labor report.

### EXPENSE REPORT

- This report should accurately document your <u>expenses</u> for this project.
- This report is an important part of the workbook and should include all <u>parts and supplies purchased</u>, a brief description of the item, the cost, and where it was purchased.
- Please total the <u>cost of the purchased items and include an</u> <u>estimated value</u> of any donated items.
- On page 15, you will find an <u>example</u> format for your expense report.





### SAFETY REPORT

- Student safety is one of Chevron's top priorities in this competition..
- <u>Document all safety precautions</u> used during the restoration of this project. Include pictures showing lifting equipment, stands, welding safety, sand blasting and painting equipment, etc.
- Document all personal protective equipment used during the restoration of this project. Include pictures showing gloves, safety eyewear, dust masks, sand blasting protections, paint suits, breathing apparatus, etc.
- Document any safety features on your finished project such as guards, safety decals, flashing lights, etc. Don't be alarmed if your project has few safety features, we understand that many older tractors were built with very few of these.
- Remember safety is very important! Plan appropriately before you start each phase of your restoration. Consider safety planning with a Job Safety Analysis (JSA). Templates can be found through an Internet search.

# **DISCOVERY ESSAY**

In this section you will want to include a short essay (1-2 pages) describing what you and your team have learned and experienced during the restoration. Here are some tips for what you can include:

- What was the best part of the project? The most memorable?
- What did you learn about yourself or your teammates?
- Tell us about any teamwork involved to be successful. How did you divide the work? Track your time and expenses? Plan and manage your budget?
- What were the best parts of the restoration or the most rewarding? What were the worst parts?
- Did you learn anything about yourself that surprised you?
- What would you do differently if you had it to do all over again?
- Was there anything special about this tractor? Was it owned by a family member? Was it a limited production?



It's always nice to acknowledge people who helped you in your restoration project. Don't forget to use social media to recognize those individuals and organizations who helped you along the way!



# **SAMPLE EXPENSE REPORT**

This form can be used to document your expenses and donated goods and services, or you can develop your own form. It's good to include the estimated value of donations if you can. You may include as many pages as you need to document your expenses and donations.

### TIP:

Be sure to keep all receipts. It's a good idea to document your time, materials, and notes daily during your restoration.

\*Be sure to total the expenses at the end of your report.



# **SAMPLE LABOR REPORT**

This form can be used to document your team's time spent on the restoration. It is not necessary to record your advisor's time. However, any donated services should be captured in your expense report (e.g. machine shop work) with donated goods and services. You can develop your own form and you may include as many pages as you need to document your team's time.

- Don't forget...this is a project sponsored by Delo (rhymes with "Jello").
   If you would like Delo product donated for your restoration, see page 40 for instructions on how to locate a Chevron marketer (distributor) and request the product. It is highly suggested not to include competitive products in your workbook or video since this competition is sponsored by Delo.
- Pictures help tell the story so feel free to use as many as you like in your workbook to document your project. Pictures should be large enough to be able to see what is going on in the photo and include captions with your photos so the judges know what you are trying to show or communicate.
- Descriptions and narratives should tell the story as well, but use brevity.
- Don't take credit for work you did not perform. If you use an outside source to help you with any portion of the restoration effort, document it. Your resourcefulness counts!
- Don't assume the judges know as much about your tractor and/or farming as you do. Even though
  the judges are professionals, you should present your work with full descriptions, making it as selfexplanatory as possible.
- Don't include information that is not relevant. Go through each section and ask yourself "is all this
  information necessary? Have I missed anything important?"

# **RESOURCES & RECOMMENDATIONS**

- Workbook files may be quite large due to the number of photos and therefore cannot be sent via regular email. HighTail.com is a web program which offers free limited service where you can upload and send large files. Other options that may be available are icloud.com (apple), OneDrive (Microsoft), Dropbox.com, or Google Drive. Visit their respective websites for instructions. If you still have difficulty with electronic upload, call or email the TRC coordinator for assistance. All entries must be received by midnight on the competition deadline.
- It is strongly recommended that your final workbook be converted and submitted as a PDF file, though this is not mandated. If you have Microsoft Word 2007 or later, you can save your document as a .pdf file. If you have an older version of Microsoft Office or do not have the ability to create a .pdf document from a Word document, you can download a free program, PrimoPdf.com. Follow the instructions to create your Primo PDF.
- Other workbook resources: A workbook template has been developed and supplied in Microsoft Word®. If you do not have Microsoft Word, you can use any program you like, we strongly recommend your cover page follow the format provided in the template and include your team name, school or FFA, a photo of your restored tractor and a caption with the year, make and model of the tractor.
- Open source software is available free at OpenOffice.org if you don't have Word.
   The Word template can be opened in the Open Office word processing software and submitted. If you need help with Microsoft Word or open source software, look for volunteer assistance.
- Chevron Delo products may be requested. See page 40 for instructions on how to request Delo product donations.



### TIP:

With so many photos in a workbook, you may find file size becomes an issue. You may need to compress your images or use lower resolution shots. You can find online resources for the program you are working in (e.g. Microsoft Word) that guides you through picture compression.

# TIP:

Be sure to save your workbook file frequently. It's not uncommon for programs to close suddenly — you don't want to lose your work!

# **VIDEO SUBMISSION GUIDELINES:**

A 3-4 minute video must be submitted with each team's entry in order to qualify for the Delo TRC competition. Video adds sight, sound, and motion, but you can also use still photos to create parts of your video. However, the judges do want to see and hear your tractor running. Be sure to take footage of starting and running your tractor so the judges can see your restoration project is complete! Any submission received without a video will be disqualified. Judges will view the videos for information regarding your restoration project.


**Royalty-free music** can be found on websites such as **FreeMusicArchive.org**. Be sure and look for education options which may be less restrictive.

Note: While you may wish to include a song by a top artist, their music is likely protected by copyright laws and should not be included. Such use is copyright infringement.

# **VIDEO REQUIREMENTS:**

- A 360 degree walk around of the finished tractor so the judges can see the restoration from all angles
- The tractor being started from the driver's seat with footage of working gauges
- Operating the tractor in forward (through all gears) and reverse
- Operation of PTO, brakes, hydraulics, three-point hitch, etc.
- Show functioning gauges
- Limit video to 3-4 minutes in length

**Remember:** Competition judges will review your video to gain a better understanding of your finished restoration.



The 2019 Best Video contest has been designed to engage families, friends, and the communities in another aspect of the competition. The online video vote outcome does not affect the final outcome of the competition. The following are rules for the online Best Video Competition:

- The videos will be voted on by the public.
- The Online Video Vote Contest is a standalone contest and has no influence on the selection of finalists, or the outcome of the competition.
- One winner and one runner up will be selected as part of the video voting competition.

# FINALS PRESENTATION OVERVIEW

If selected as a finalist, you will be invited to present your project during the National Finals, held in conjunction with the National FFA Convention in October each year. You will compete for placement and prize money. Delo TRC judges are all experienced in tractor restoration and will listen to your oral presentation and ask detailed questions about your restoration.

RESTORATION COMPETITION

Making a great presentation takes confidence, knowledge, and preparation. You've restored your tractor and now it's time to present to the judges. Here are some tips to help you prepare and deliver the best presentation!

- It helps to start with an outline of what you want to cover and key points—your presentation should feature all the highlights of your projects including what you learned.
- Decide how you want to present the information, and then organize it so that it makes sense. Be confident! You did the work, now it's time to show off what you found and learned. It's ok to be entertaining—be relaxed!
- Practice and rehearse! The best presentations are not memorized but are wellrehearsed. Practice in front of friends and family. Ask for feedback after your practice sessions so that you can improve your presentation.
- Use visuals—bring old tractor parts and tell the judges how each piece works or what you found as you dissassembled your tractor. Talk about what was wrong when you began your restoration project and how you repaired or restored. What challenges did you face? How did you overcome them? Remember, props and demonstrations are great provided they help tell the story, but don't rely on videos and photos to tell the story for you. Tell the judges what you learned.
- With more than one presenter, it's recommended that each presenter choose an area of expertise to focus on. Be a subject matter expert for your particular role in the restoration. If one team member will graduate the year before your submission, be sure and transfer the knowledge so another student can tell the story, if your team is selected as finalist.

Hint: there are public speaking organizations, such as Toastmasters International (toastmasters.org) that offer fellowship and structure for learning and polishing your public speaking skills. The best presentation will be recognized in the 2019 competition. The live presentation portion of the program is an excellent way to learn and practice valuable public speaking skills, which you will use as you meet other challenges in life. Plus, the best presentation wins a \$100 gift card per team member up to 5 or \$500 total. Team members must be listed on the original entry form.


# TABETHA SALSBURY: 2003, 2004 GRAND CHAMPION

# What Mr. Holst looks for in Delo TRC workbooks, presentations and projects:

- "Safety is the first thing that I look for, safety in the task that you are doing in a picture as well as safety of what is in the background. For example while grinding and using all the proper PPG, is your extension cord in a grounded outlet? If there is water or other liquids nearby. How safe are the people who are assisting you?"
- "I like to see the life lessons learned from the project. Make sure you have fun with it but also show/tell me what you learned and why it is important to you."
- "Everyone who is selected to present as a finalist has done a superb job to reach this level. However to be chosen the winner it will take paying attention to the details. Knowing every aspect of the restoration process is important. I strongly encourage everyone to perform a complete teardown, component assessment and /or rebuild. Be prepared to explain the path that was taken in the restoration process."

- "When I look at the workbook I want each section to have detailed descriptions of the work

# TRACTOR RESTORATION COMPETITION

# Q: Who is eligible to compete in the Chevron Delo® Tractor Restoration Competition?

A: All high school students are eligible to compete in the Chevron Delo Tractor Restoration Competition (TRC). Any student on the team may graduate during the academic year prior to the competition deadline in August and still compete in finals if the team is selected

### Q: Is there a certain type of tractor I must restore?

A: Tractors must have internal combustion engines. Historically students restore tractors that were once a vital part of daily farming.

### Q: Can I/we have help?

A: We encourage parents, agriculture teachers and advisors to be active in your restoration project from an advisory standpoint. They should be there to supervise and offer help with questions, explain best practices, observe and enforce safety precautions, and be your go-to person for any questions. However, this is a student project. Advisors and parents should not be completing the workbooks or restoring tractor components without student involvement. We also encourage students to reach out to the community and Chevron lubrication marketers (distributors) who may also provide advice or technical information. Visit **DeloPerformance.com** to locate a Chevron marketer (distributor) in your area. See page 40 for instructions on how to request product donations.

### Q: This project could be expensive—how do teams manage?

A: Cost management and budgeting will be valuable skills learned through your restoration effort. It's a good idea to set an initial budget and track your budget along the way. Be sure and document how you manage it in your workbook. Some students may have sponsors who underwrite their project expenses so it's important to document for your accountability. How you manage your resources (time and materials) is more important than the total cost of the restoration. Always think about the return on investment. For example, is it worth buying a new fender when you can weld in a replacement patch?

# Q: Are there any resources for helping to finance the restoration?

A: Here are some ways that you might consider raising funds for your project:

- Hold yard sales at your school and ask for donated items and baked goods from local businesses
- Host car washes at a local business
- Use social media to ask for help—you might be surprised what you will get. Be sure and tell your story so folks will want to get involved and help.
- Start a GoFundMe (GoFundMe.com or Facebook.com/GoFundMe)
- Reach out to antique tractor clubs or tractor enthusiast clubs for donations and/or expertise. You may even find a sponsor or benefactor.
- Print and sell t-shirts
- Sell DeloTRC calendars (request order information by email: TRC@DeckelMoneypenny.com)
- Contact your local Delo marketer/distributor (**deloperformance.com/en-us/find-a-marketer.html**) or email **TRC@DeckelMoneypenny.com** to request donated product
- Titan Tires has a history of product donations. Information can be found on their website, **titan-intl.com** or **titan-intl.com/antique-tractor-restoration**
- If you are aware of other resources that you'd like to share with other student teams, please send an email to TRC@DeckelMoneypenny.com, or post it on our Facebook.com/DeloTRC page.
- Sell tickets to raffle off the tractor after the competition

# **GETTING STARTED**

# Q: Where do I begin? Where do I get a tractor?

**A:** While Chevron sponsors this competition, we do not provide or have any specific knowledge as to where you can get a tractor. Drive around your town or rural surrounding areas. Check the papers to see if anyone is selling an antique tractor, or to find upcoming auctions. Check with your School Ag advisor – they may be able to assist you in finding a tractor. If you are interested in restoring a specific make tractor (e.g. Allis Chalmers, John Deere, Case, etc.) you may find collector clubs and individuals who might help with expertise or even sponsoring a restoration. Social media can be used to promote your desire to locate and restore a tractor.

# Q: What kind of tractor am I looking for?

**A:** There aren't many rules regarding the types of tractors that you can restore for this competition. We don't have a rule regarding the age of the tractor or the model of the tractor. However, it does need to have an internal combustion engine and be a tractor that, in its past life, was an important working member of the farm. This program is sponsored by Delo. If your tractor doesn't need any lubricants or coolants, it's probably not the right type of tractor. If you are in doubt, please feel free to contact the TRC Coordinator by email at **TRC@DeckelMoneypenny.com**, text or call (502) 513-7001, or call toll free (800) 501-7469.

# Q: I've registered and downloaded the Workbook template file, but it won't open on my computer. What's wrong?

**A**: The 2019 Chevron Delo Tractor Restoration Competition is a green submission process and the workbook template is provided in Microsoft Word®. If you do not have Microsoft Word, you can download open source software which will allow you to open the document and incorporate your content. Go to **OpenOffice.org** to download open source software. Your workbook must be incorporated into the Word template and sent to the competition electronically. If you need technical assistance with the format of the 2019 workbook, please refer to your software (Word or Open Office). For general questions about the workbook submission please contact the TRC Coordinator by email at **TRC@DeckelMoneypenny.com**, text or call (502) 513-7001, or call toll free (800) 501-7469.

If you are using a Mac computer and have the Pages software installed, you should be able to open the Word template.

# Q: I've registered for the program and downloaded the TRC Instruction book and workbook template, but what if I don't finish my project and decide not to submit it for consideration in this year's competition?

**A:** Registering to get the workbook does not, in any way, obligate you to submit the workbook for the current year's competition. We know that finishing a project such as this is hard work and you have other priorities. Feel free to use the instruction as a guide as you go along during your project. Please note that if you do not complete and submit your restoration during the current year, the instruction book may change the next year.

### Q: I don't have Word — what do I do about the workbook template?

A: Refer to workbook resources on page 18. However, the only requirement is to include the cover page information so you can work in any program you choose.

### Q: Help! My photos are moving around in my workbook file! What should I do?

**A:** Photo placement tips can be found online on your software program's website (e.g., Microsoft Word). Proper placement of photos in your document will prevent photos from moving around and potentially obscuring text that describes a portion of your restoration.

### Q: How do I submit the workbook?

**A:** Workbooks must be submitted electronically to **TRC@DeckelMoneypenny.com** by the competition deadline. Refer to the instruction book for additional details of the submission process with respect to emailing large files. We no longer accept printed workbooks. All required submission materials (workbook, video, before/after photos) must be received by midnight of the competition deadline. We encourage teams to submit early — planning ahead reduces deadline stress.

### Q: What should be in the workbook?

**A:** The TRC judges will refer heavily to your workbook to evaluate your restoration. Be sure to include all the topics outlined on pages page 10-16.

### Q: When do I need to get my completed TRC Workbook to you?

**A:** The deadline for workbook submissions is August 19, 2019, but it is best if you try to get your workbook in early. We encourage students and teams to submit their registration and release forms early and in advance of the competition deadline so we know to look out for the electronic workbook, photos and video submissions.

# THE FINALS

### Q: My team has been recognized as a Finalist! What happens now?

**A:** Congratulations! Finalists will be notified first on Facebook, followed by an official email with details about the live presentations which will be held during the FFA Convention. Finalists will be invited to deliver an oral presentation on their restoration project to the judging panel. All participants are responsible for their travel expenses. Once selected as a finalist, be sure to make arrangements as soon as possible to attend the convention. **You won't be able to bring your tractors with you**— just you and/or your team, and your parents/guardians/student advisors.

### Q: What happens during the Finals?

**A:** At the finals, you will present your restoration project to a panel of expert judges. The judges will have reviewed your workbook and video so be sure to present new information. Feel free to use any type of visual display – PowerPoint presentations, storyboards, actual parts from the old tractor, etc. The judges want to get a sense of who you are, what you discovered and learned.

After you give your presentation, there is a Q&A period where the judges can ask you questions about your presentation and/or your project. Be prepared to know specifics about tasks that you performed and your documentation. See section on Competition Planning for suggestions

## Q: An Oral Presentation? What should I do?!

**A:** You've done the hard work of restoring your tractor. The oral presentation provides the opportunity for finalists to present their project from start to finish. The judges will have seen your workbook and will be familiar with your documentation. Try to include new information or highlights of your project.

It's perfectly acceptable to have your talking points written on cue cards or index cards. We know how easy it is to lose your train of thought when you're nervous. While it's awesome if you can memorize your speech...don't feel obligated to do so. We want you to be totally comfortable talking to the judges. Remember that there may be community resources such as Toastmasters International to help you with public speaking skills. *Practice* is very important — Don't try to wing it!

## Q: What happens after I give my presentation?

A: Finalists teams present over the span of two days during the October National FFA Convention in Indianapolis on Wednesday and Thursday, and the Awards Ceremony follows on Thursday evening. All finalists will be recognized at the awards ceremony. Chevron executives will present the program and winners.

But don't forget... You Are All Winners. Restoring a tractor is hard work and you should be proud if you make it to the finals—it's quite an accomplishment!

### Q: Who is invited to the Awards Ceremony?

A: All finalists will receive an invitation to compete at Nationals. We will need to know from all finalists how many people to expect at the Awards Ceremony. Generally the student advisors and the students' parents attend the Awards Ceremony. We have limited seating so additional family members are welcome, within reason, provided we still have seating available. We need to know how many to expect ahead of time.

## Q: I am grateful to the judges and Chevron for their time and review of my project. Is it ok to give them a memento of appreciation?

A: While it is a nice gesture to thank the judges and Chevron, we respectfully ask that no gifts of any monetary value be given to the judges as it may create a perception of favoritism. After the judging is complete and winners announced, if vou would still like to express appreciation, please reach out to the Delo TRC coordinator by email and your comments will be shared.
